



The **House of Commons** has recognized Canada's Indian Residential School system as an act of genocide.

On Thursday, the motion brought forward by NDP MP **Leah Gazan** was adopted by unanimous consent.

"Today I lift up survivors, families, and communities who have sacrificed so much in order for people across Canada to know the truth; that what happened in residential schools was a genocide. I'm grateful to parliamentarians who unanimously passed my motion recognizing the truth of Canada's history," Gazan said in a news release.

"I look forward to working with the government to ensure the will of Parliament is honoured by formally recognizing residential schools as a genocide. Survivors deserve no less."

Article II

Robert Carney, historian and father of Mark Carney

- *historian Robert Carney said (father of the more famous Mark Carney, former Bank of Canada and Bank of England governor) in his critique of the Royal Commission on Aboriginal Peoples report, “But unlike most other boarding schools whose objective was to school children in a highly controlled residential setting, Aboriginal boarding schools were multipurpose institutions that took in many children who suffered from various forms of social, emotional and physical distress. The chapter contends that these “social welfare” functions did not become prevalent until a decade or two before the schools were closed. The fact is that Aboriginal residential schools always played a major role in caring for children in need..... **It would have been fair to acknowledge [in the Royal Commission report] that many traditional [Indian Residential School] boarding schools, in some cases well into the twentieth century, took in sick, dying, abandoned, orphaned, physically and mentally handicapped children, from newborns to late adolescents, as well as adults who asked for refuge and other forms of assistance.**”*

So, unidentified graves may be found – of people unrelated to the schools



- [Moffat et al \(2013\)](#) in “*Sanitoriums and the Canadian Colonial Legacy: The Untold Experiences of Tuberculosis Treatment*” note that “within the context of TB, public health officials were granted the authority to coercively institutionalize the affected, forcibly removing infected individuals and placing them in sanitoriums (Shedden, 2011)”. Due to the long treatment periods, contact with family, culture and heritage was lost. One aboriginal testimonial in Moffat reads: “My brother went to the sanatorium and stayed there for seven years because he was allergic to the medication. It took seven years for the tuberculosis to go dormant. I never knew my brother. My older sister has no memory of him. My siblings never met their brother until he was thirteen. He was a total stranger. That’s the emotional part — that we had a brother we never knew.”





TB – Captain of all these men of death

- TB most commonly infects the lungs, though it can infect almost any part of the body, including the heart, the bones, or the brain. Typically, the immune system is able to form a protective layer – a tubercle – around the bacterial infection, but in some people the bacteria are able to continue to replicate in the tubercle until it bursts, damaging lung tissue and releasing bacteria that spread further into the lung and body.

Ambiguous Losses

- *One need only read this sad story in Eric Bays' book, "Indian Residential Schools: Another Picture." Bays explains that at the Hudson's Bay trading post at Albany, a father showed up saying there was no food in the family tent and that his wife was ill. The father then died. The Hudson's Bay sent out men with food, only to find the family in a tent, the mother deceased with five children around her. A two-month-old baby was given up to a relative, the 16-year-old joined other relatives on a hunt, and the remaining three children, a boy and two girls, came to the residential school. During a flu epidemic, the youngest of the three died at the school.*
- *This vignette is a repeating story through the history of Indian Residential Schools. Orphaned children. Families in distress. This also is an example of why many Indigenous people 'know' there are missing children from their communities — and why they feel certain the loss is directly associated with Indian Residential Schools.*

Location of death

For 1,391 of the 3,201 deaths (43.5%) on the Named and Unnamed registers combined for the period from 1867 to 2000, there is no known location of death. Table 4 reports on the location of the 1,810 deaths for which there is a known location of death.

China calls for Canada human rights inquiry, preempting demand for investigation into abuse of Uyghurs

Just moments before Canada was due to issue a call for an international investigation into crimes against Uyghurs in China's Xinjiang on Tuesday, a Chinese diplomat stepped in with Beijing's own proposal: an investigation into Canada.

“We are deeply concerned about the human rights violations against the Indigenous people in Canada,” Jiang Duan, a senior official at China’s mission to the United Nations in Geneva, said at a meeting of the U.N. Human Rights Council.

Referencing the recent discovery of the remains of 215 children at the former Kamloops Indian Residential School in British Columbia, Jiang said China and its allies sought a “thorough and impartial investigation,” not just of the discovery but of broader Canadian crimes against Indigenous people.

Among those allies are autocratic countries also accused of human rights abuses, including Belarus, North Korea and Syria.

Dueling Demands on Genocide: China and Uyghurs vs Canada and Indians

The dueling demands represented a deep geopolitical and ideological divide at the top U.N. human rights body. Iran, Russia and Venezuela also backed China's demands for an investigation in Canada.

The remains found in Canada included those of Indigenous children as young as 3, shocking many Canadians.

In 2015, the Truth and Reconciliation Commission of Canada concluded that the forced separation and cruel treatment of Indigenous children at the schools between 1883 to 1996 constituted "cultural genocide."

While Canada was providing education, food, clothing and skills to Indigenous children, China was starving 40 million of its own people in a state-sponsored genocide. A real one.







Ground Penetrating Radar Cannot See Bodies, Remains or Coffins



GPR Contribution to Solution

In soils that are favorable for GPR, sandy or silty soils, as was the situation in this case study, buried, intact coffins are often strong reflectors of GPR signals and appear as strong hyperbolas or localized flat reflectors, depending on the shape of the coffin. Examples of GPR reflections from coffins are shown in Figure 1 and 2.

Dr. Sarah Beaulieu, a University of the Fraser Valley (UFV) anthropologist, presented a summary of her ground penetrating radar (GPR) investigation to media Thursday morning at an event held by Tk'emlúps te Secwépemc First Nation, highlighting 200 "targets of interest" of what are likely to indicate human burials.

The Tk'emlúps te Secwépemc First Nation have identified Beaulieu as a collaborating researcher whose work confirmed the probable unmarked graves on the grounds of the former Kamloops Indian Residential School (KIRS).

Beaulieu emphasized that remote sensing such as GPR is not the only means of knowing children went missing in Indian Residential School contexts. Beaulieu added that this fact has been recognized by Indigenous communities for generations, and that remote sensing provides specific coordinates to this truth.

Beaulieu, a specialist in conflict archaeology, joined Tk'emlúps te Secwépemc Chief Rosanne Casimir, Tk'emlúps te Secwépemc Legal Council, KIRS survivors and other experts at **the virtual and in-person gathering** at the Coast Kamloops Hotel & Conference Centre.


"My findings confirmed what Elders had shared," Beaulieu said after the event. "It's an example of science playing an affirming role of what the Knowledge Keepers already recognized."



Land Back is an Indigenous-led movement with a rich and complex meaning. In the words of Isaac Murdoch, "Land Back is people returning back and finding their place in those systems of life."

According to journalist and Canada Council for the Arts chair Jesse Wente, Land Back is "about the decision-making power. It's about self-determination for our Peoples here that should include some access to the territories and resources in a more equitable fashion, and for us to have control over how that actually looks."

Systems of land governance under our current provincial and federal governments not only exclude Indigenous Peoples from decision-making tables where choices about land use are made, they also fail to set limits for industrial activities and development, driving wildlife decline and ecosystem degradation.

The David Suzuki Foundation believes that land governance in Canada must change to recognize and uphold Indigenous rights and responsibilities, and to restore nature's once abundant ecosystems.





Background and Context of the Missing Children and Unmarked Burials

1. The existence of unmarked graves and burial sites of children who died while being forced to attend Indian Residential Schools¹ in Canada is a stark reality of the ongoing harm of assimilative government laws and policies that have targeted Indigenous Peoples. The Indian Residential School System was put in place for the express purpose of "killing the Indian in the child" and has been characterized as genocide by the Truth and Reconciliation Commission of Canada (TRC, 2015), Canada's National Inquiry on Missing and Murdered Indigenous Women and Girls (MMIWG National Inquiry, 2019) and by the Canadian House of Commons (2022).
2. For over 100 years, more than 150,000 First Nation, Inuit and Métis children were taken from their parents and communities and placed in state-funded, church-run Indian Residential Schools. Based on significant documentary evidence and Survivor testimony, the TRC concluded that many children who were forcibly taken to these institutions were subject to neglect, malnutrition, substandard health and living conditions, exposure to contagious diseases, mistreatment, medical experimentation, and extreme physical, sexual, spiritual and mental abuse by those entrusted with their care.
3. Unfortunately, many First Nations, Inuit and Métis children were never returned home from Indian Residential Schools. Survivors have shared testimonies of children who were there one day then disappeared the next, of newborn babies being put into incinerators, of being forced to dig the graves of children who died, and of knowing where on former Indian Residential School grounds children are buried in unmarked graves.

The herein is a Communication and Referral (the “Complaint”) seeking a Preliminary Examination of the Prosecutor of the International Criminal Court (ICC) be commenced *proprio motu* pursuant to Article 15 of the *Rome Statute of the International Criminal Court*¹ (the “Rome Statute”).

The Complainants are lawyers in the Member State of Canada. The accused/suspects are agents, employees or actors working for the Government of Canada (“GOC”) and the Government of Vatican City State/Holy See (“Vatican”). These agents, employees and actors would be specifically known by the GOC and Vatican via their respective records.

The Complaint is regarding the recent discovery of a mass unmarked grave of 215 Indigenous children who were under the forced care of the GOC and the Vatican. The death of the 215 Indigenous children resulted from their enrolment in the GOC residential school system forced on the Indigenous peoples of Canada by way of GOC legislation and administered by both the GOC and the Vatican. The specific school where the mass grave has been discovered is the Kamloops Indian Residential School in British Columbia. At one time, this school was the largest residential school in Canada. It was open and had students enrolled in it until 1978.

Cemeteries are evidence that we are all mortal. Ask these questions.

- 2 Who are their families?
- 3 How did they die?
- 4 When did parents or guardians report them missing?
- 5 Why are the RCMP not investigating?


De Facto Reparations, Uncontested in Court due to the Wilson-Raybould Directive

- Reparations began with the Indian Residential Schools Settlement Agreement, finalized in 2007, which awarded almost \$5 billion (2007 dollars) in individual payments to those who had attended the schools. Class actions regarding other forms of education were launched, but the federal Justice Department resisted these claims until 2015, when Justin Trudeau's government came to power. The new Minister of Justice, Jodi Wilson-Raybould, instructed departmental lawyers to seek negotiated settlements instead of litigating vigorously. These instructions were formalized in her "Litigation Guidelines," which were issued in 2019 and are still in effect.
- The cost of claims approved thus far is \$27.8 billion in payments to individuals and \$31.9 billion for payments to organizations and promises of improved services, for a total of almost \$60 billion (2023 dollars). Claims now in progress are likely to add significantly to these sums.
- The Canadian practice appears to seek compensation for damages for individuals, but the government's unwillingness to contest these claims, at least since 2015, has turned them into a kind of de facto reparations. Claims are made in virtue of alleged historical mistreatment under this or that federal program; but when the claims are not contested, and no proof is sought of actual damages, they become the equivalent of reparations—but never discussed in the legislature and ratified by public opinion. In effect, Canada is enacting reparations by stealth

For more than two decades, Pew has supported Indigenous-led conservation, including since the late 1990s in the Northwest Territories. Along with other partners, Pew provided direct financial assistance to First Nations to engage in land use planning, to establish Indigenous protected and conserved areas, and to expand Indigenous Guardians programs—complemented with in-kind communications, policy analysis, and networking and partnership building support.

In 2021, Pew and other partners came together to form the [Enduring Earth](#) collaboration, whose goal is to work with local partners to protect 600 million hectares in PFP initiatives around the world by 2030. The Northwest Territories will be among the first phase of PFPs completed with [Enduring Earth's](#) support.

The Upshot? Land title and resource development is turning upside down. Just as the six provincial leaders feared.

International Commissions of Inquiry, Commissions on Human Rights, Fact-Finding missions and other Investigations


United Nations-mandated investigative bodies are increasingly being used to respond to situations of serious violations of international humanitarian law and international human rights law, whether protracted or resulting from sudden events, and to promote accountability and counter impunity. These investigative mechanisms have been established by the Security Council, the General Assembly, the Secretary-General, the High Commissioner for Human Rights, the Human Rights Council, its predecessor, the Commission on Human Rights.

Investigative bodies mandated by the Human Rights Council have taken numerous forms since the Council was created in 2006, including fact-finding missions and commissions of inquiry. Most have been established to investigate alleged violations in specific countries. However, one – the Expert Mechanism to Advance Racial Justice and Equality in Law Enforcement – is thematic in nature. A full list of current and past mandates can be found on the [link](#).



Indian Residential School Facts

- Education was offered in the treaties and chiefs and councils requested education, particularly skills training like literacy, agriculture, industry, medical and clerical
- Parents had to register their children to attend; schooling was not mandatory until 1920 in keeping with truancy laws.
- Detailed death certificates were issued if TB, disease or injury caused a death.
- Some children were orphans with no one else to help them and nowhere else to go.
- Residential schools served as the regional social services/medical hub in the early days. In 1908, 1 Canadian died every hour of the day; 2 died every hour of the night from Tuberculosis (TB).


